PUBLIC NOTICE TO VOTERS OF ESSEX COUNTY

You are hereby informed of the following procedure that will be used for the **SPECIAL GENERAL ELECTION** to be held on **APRIL 16, 2026**.

(1) any person attempting to vote may be challenged by a candidate, by the duly authorized challenger for a candidate or a political party or on a public question, or by a member of the district board of elections, because the challenger or board member has good cause to believe that the voter is not entitled to vote;

(2) members of the district board and all duly authorized challengers are prohibited from challenging, delaying or preventing the right to vote of any person because of that person's race, color, national origin, expected manner of casting a vote or residence in a particular ward; housing complex or section of a municipality or county;

(3) a person who is challenged may seek to establish his or her right to vote by swearing out and signing an affidavit attesting to the voter's qualifications and/or providing a suitable identifying document for inspection, which may be--but is not limited to--the following: a valid New Jersey Driver's License, a sample ballot with the voter's name and address, an official Federal, State, County or Municipal document, a current utility or telephone bill or tax or rent receipt or a piece of mail postmarked on or after the 60th day before the election; a copy of the affidavit shall be given to the challenged voter; the district board shall determine the validity of the challenge by voting on it pursuant to N.J.S.A. 19:15-24;

(4) any person who is challenged by a duly authorized challenger or by a member of the district board of elections may seek to establish his or her right to vote by swearing out and signing the affidavit and/or providing the proof described in paragraph (3) above; the district board shall determine the validity of the challenge by voting on it pursuant to N.J.S.A. 19:15-24;

(5) any challenger who succeeds in denying a voter the right to vote must sign an affidavit stating the reason why the voter is not entitled to vote and must furnish a copy of the affidavit to the challenged voter; the district board may, in its discretion, require that the challenger affidavit be signed when the challenge is made;

(6) and person who is denied the right to vote by reason of a successful challenge made at the polls may seek permission to vote by going before a Superior Court Judge to seek a court order allowing that person to vote; the applicant should take copies of any affidavits given to him or her at the polls and any proof submitted at the polls in support of that person's right to vote;

(7) forms to register complaints about the conduct of an election shall be available at each polling place in the county.

AVISO PÚBLICO A LOS VOTANTES DEL CONDADO DE ESSEX

Por la presente se le informa sobre el siguiente procedimiento que se utilizará para la **ELECCIÓN GENERAL ESPECIAL** que se celebrará el **16 DE ABRIL DE 2026**

(1) cualquier persona que intente votar puede ser recusada por un candidato, por el retador debidamente autorizado de un candidato o de un partido político o sobre una cuestión pública, o por un miembro de la junta electoral de distrito, porque el retador o miembro de la junta tiene motivos fundados para creer que el elector no tiene derecho a votar;

(2) a los miembros de la junta de distrito y a todos los retadores debidamente autorizados se les prohíbe impugnar, retrasar o impedir el derecho al voto de cualquier persona debido a su raza, color, origen nacional, forma esperada de emitir un voto o residencia en un lugar en particular. pabellón; conjunto de viviendas o sección de un municipio o condado;

(3) una persona impugnada puede tratar de establecer su derecho a votar prestando juramento y firmando una declaración jurada que acredite las calificaciones del votante y/o proporcionando un documento de identificación adecuado para inspección, que puede ser, entre otros, a-lo siguiente: una licencia de conducir válida de Nueva Jersey, una boleta de muestra con el nombre y la dirección del votante, un

documento oficial federal, estatal, del condado o municipal, una factura actual de servicios públicos o de teléfono, o un recibo de impuestos o de alquiler, o un correo matasellado a partir del día 60 antes de la elección; se entregará copia de la declaración jurada al elector recusado; la junta de distrito determinará la validez de la impugnación mediante votación de conformidad con N.J.S.A. 19:15-24;

(4) cualquier persona que sea recusada por un retador debidamente autorizado o por un miembro de la junta electoral de distrito podrá intentar establecer su derecho al voto prestando juramento y firmando la declaración jurada y/o proporcionando la prueba descrita en el párrafo (3) arriba; la junta de distrito determinará la validez de la impugnación mediante votación de conformidad con N.J.S.A. 19:15-24;

(5) cualquier impugnador que logre negarle a un votante el derecho a votar debe firmar una declaración jurada indicando el motivo por el cual el elector no tiene derecho a votar y debe proporcionar una copia de la declaración jurada al votante cuestionado; la junta de distrito puede, a su discreción, exigir que la declaración jurada del impugnador esté firmada cuando se realiza la impugnación;

(6) y la persona a quien se le niega el derecho a votar debido a una impugnación exitosa realizada en las urnas puede solicitar permiso para votar acudiendo a un juez del Tribunal Superior para solicitar una orden judicial que le permita votar; el solicitante debe llevar copias de cualquier declaración jurada que se le haya

entregado en las urnas y de cualquier prueba presentada en las urnas en apoyo del derecho de esa persona a votar;

(7) los formularios para registrar quejas sobre la realización de una elección estarán disponibles en cada lugar de votación del condado.

April 16, 2026. Go to the Polling Place of your new residence. Provisional Ballots will be available, but you should first confirm that you are a registered voter.

If you are a registered voter in a municipality of Essex County, moved to another district and or municipality of the County but did not submit a change of address to the County Commissioner of Registration, you are entitled to vote in the Special General Election on April 16, 2026. Go to the Polling Place of your new residence. Provisional Ballots will be available, but you should first confirm that you are a registered voter.

ASSISTANCE FOR PERSONS WITH DISABILITIES

Persons unable to vote at the polling place due to permanent or temporary disability may request a mail-in ballot application by telephoning the Office of the County Clerk at (973) 621-4922. The Office of the Board of Elections may be contacted for information regarding polling place assignments and assistance to voters who choose to vote at the polling place on Election Day. The telephone number is (973) 621-5073.

Pursuant to the provisions of the “Voting Accessibility for the Elderly and Handicapped Act of 1984” a telecommunications device for the deaf (TDD) is maintained at the Election Division, Department of the State, Trenton, New Jersey.
