ESSEX COUNTY DIVISION OF HOUSING AND COMMUNITY DEVELOPMENT PUBLIC NOTICE COUNTYWIDE PUBLIC HEARING ON THE 2025 CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION REPORT (CAPER)

In accordance with the U.S. Department of Housing and Urban Development regulations governing the Community Development Block Grant (CDBG) Program, HOME Investment Partnerships Program (HOME) and the Emergency Solutions Grant (ESG) Program, the County of Essex hereby notifies the public of its intent to make the PY 2025 CAPER available for review. Citizens of Essex County are invited to review the CAPER, which is the Essex County Division of Housing & Community Development's annual report to the U.S. Department of Housing and Urban Development for the CDBG, HOME and ESG Programs.

A draft copy of the CAPER will be made available for public comment at the County Office of the Division of Housing & Community Development, 20 Crestmont Road, Verona, NJ 07044 on July 7, 2026, and via the Essex County Website at www.essexcountynj.org. Citizens of Essex County are also invited to attend a public hearing at Kip's Carriage House, 20 Crestmont Road, Verona, on Monday, July 17, 2026, at 4:00 PM to review and provide comments regarding the programs administered by the Essex County Division of Housing & Community Development and the outcomes of these funded activities. All comments will be included with the submission of the CAPER to the U.S. Department of Housing and Urban Development on or about August 25, 2026. The Division of Housing & Community Development will be accepting public comments for a period of fifteen days (15) days until August 4, 2026. The Division staff will review all comments and respond to each commentator in a timely manner. Comments may be communicated on July 17, 2026, public hearing or in writing.
